- Each invoice is due and payable within 30 days from invoice date.
- If equipment is rented for more than 4 continuous weeks, periodic invoices will be issued for rental charges due. All such invoices are due and payable within 30 days from invoice date.
- Any account with a delinquent balance may be placed on a cash basis and the equipment picked up without notice, at the discretion of Fallbrook Equipment Rentals, Inc.
- Fallbrook Equipment Rentals, Inc will file preliminary lien notices whenever the total billing warrants such action. This is a company policy and is not a reflection on your credit standing.
- A service charge of 1 ½ % will be added to each delinquent account.
